Helping children, adults, and families throughout Tulare County heal from violence and thrive in healthy relationships.



- Received 116 calls to our rape crisis hotline
- Received **889 calls** through our domestic violence hotline
- Responded to 128 domestic violence chat sessions
- Completed 187 safety plans
- Served 12 survivors of human trafficking
- Served 189 sexual assault survivors survivors








- 51 adults and 60 children resided at Karen's House, domestic violence shelter

- Served 262 individuals through supportive, transitional, and permanent housing programs
